Opening:

Ms. Acksen opened the meeting at 5:05 PM and read the open meeting law for the record. She noted that the agenda items would be slightly rearranged to accommodate the meeting with Mr. Chasse.

Meeting via Zoom with Peter Chasse, Director of Dartmouth Community TV (DCTV)

Mr. Chasse began with the history of Dartmouth Community TV (DCTV). It formed in 1995 in the high school as part of the high school media program under Ms. Cyndi Marland before becoming a town department. Mr. Chasse took over for Ms. Marland last year. DCTV covers government, education, and public access broadcasting. All employees are full town employees with access to pensions and covered by unions and DCTV is funded via town meeting, though they are a separate enterprise fund. DCTV began using enterprise funds before they became widely adopted across the state.

For government access, they facilitate Zoom meetings and record the majority of the meetings. For educational programming, they cover school sports and concerts. The high school does still have its own internal program for smaller features and morning announcements. As they did not offer public access from the start, there hasn't been a good deal of community participation, though they do offer classes and allow residents to borrow cameras and editing space.

Mr. Frates explained that Fairhaven used Dartmouth's enterprise funds as a model for the two currently used – one for government and one for education. At Ms. Acksen's request for information about DCTV's staffing, Mr. Chasse outlined that DCTV employs four full time staff members, four to six part-time workers. It also takes in two to three students from U Mass Dartmouth as a part of the work-study program and has just started to bring in high school interns. For the full-time staff, they work up to six days a week, up to 40 hours, with a very flexible schedule. Sporting events will have an entire crew of six to seven staffers, covering two to three matches per week during the seasons. They do cover events on the weekend, though Sundays are considered to be overtime for full-time staff members so events on that day are often covered by part-time workers.

Mr. Methia inquired about DCTV's educational coverage and if they fund any teacher positions. Mr. Chasse explained that they do not fund teacher positions, as the high school media program is fully funded through the schools. Rather than using percentage-based allocations to education or government coverage, instead DCTV works with their internal schedule and funding to cover both as

best as they can. DCTV does occasionally gift used equipment to the schools and has purchased plaques for the students though.

After praising DCTV's robust game production, Mr. Methia then turned the conversation towards recording school plays and events, with a particular focus on rights and clearance issues with the use of the student images on access. Dartmouth Schools put out a request at the start of the year for parents to sign off on allowing their children to be recorded and the majority of parents do allow it – Mr. Chasse citing around 95% acceptance. Concerts can be broadcast as those rights are included along with the performing rights. As for plays and musicals, those are recorded for school use only upon request, but are not broadcast due to the cost. In terms of other education events, they work to record PTO meetings, updates from the principals, field days, graduations, feature nights, talent shows, and award nights.

When Ms. Acksen asked for more information about rights for showing plays and musicals by local writers, specifically citing New Bedford's Culture*Park, Mr. Chasse replied that they were able to show a musical by the high school drama teacher. As most agreements allow for cast and crew recording, DCTV works to record the shows and then the high school media program handles selling the DVDs to the cast as a small fundraiser.

Mr. Frates then turned the discussion towards the recent revenue trends with Comcast. For Dartmouth, there was a 2-4% decrease over the last few years but the last two quarters have been trending upward. Subscriber numbers have remained steady at approximately 11,000. Currently, they only have a contract with Comcast though they did also reach out to Verizon and RCN several years ago. They are in the last year of their contract with Comcast and will begin negotiations in October for the new one. He does have concerns about the differences between his projection for the budget versus the projection of expected revenue.

As to whether DCTV had more viewers on cable or live streaming, with the changes since the pandemic, they commonly see 250 viewers of their live streamed football games on YouTube with their highest concurrent viewer count being 350-400 viewers during a hockey game. However, the older audience does continue to favor the cable channels. They are planning to launch OTT services for Apple TV and other smart TVs via Tightrope Media's Cablecast system. Mr. Methia noted Fairhaven's caution towards broadcasting via OTT and social media in case of breaching the terms of Comcast's contract, which Mr. Chasse agreed with. However, he noted that the town has plans for a possible change to tax funding or charging the schools and university for their services if they lost Comcast's funding. The pandemic has made government access all the more vital, with Mr. Chasse specially noting the success of Dartmouth's virtual town meetings and school sports broadcasts.

When bringing up other sources of funding, DCTV has worked with some of the local non-profit organizations, though often free of charge. However, they considering creating a rate card to allow for renting out studio space, trucks, or services, but that might require hiring more staff. There is also the possibility of regionalization and working with Westport. All of those are longer-term options as they are currently sufficiently funded for the next two to three years. They are also anticipating receiving another ten-year contract from Comcast – while occasionally towns receive five-year contracts, ten remains the expected standard.

When asked to describe the studio space, Mr. Chasse explained that 10-12 years prior they moved into their current building, the Old Town Hall at 247 Russells Mills Rd. It contains a 20' x 25' studio space, an editing room with two to three computers, a conference room, a break room/cooking show set, and some storage space. The building was built between 1910-1915 and while they renovated the interior, the exterior still retains its original character.

As for their cable lawyer, DCTV is currently working with Mr. Bill August who assisted with their contracts in 1994 and 2004. In 2013, they worked with Mr. William Solomon, but have decided to return to working with Mr. August. There were no follow-up questions after that and Mr. Chasse was thanked for his time.

Afterward, the committee discussed reaching out to Mr. James C. Marshall, the station manager for New Bedford cable access as they had recently acquired a new 10-year contract with Comcast. Mr. Frates also would like to reach out to Comcast before the time for contract renewal to see about acquiring an HD Channel as that is now standard with their more recent contracts.

In terms of encouraging the education side, Mr. Mike Fernadaes was granted some equipment. He would like a stipend to cover at least a single camera recording of events. There are also the complications of editing a game over the weekend. They also discussed the games broadcast on nfhsnetwork.com which uses a very simple tracking camera and has no audio, scores, or commentary. The subscription service costs \$100 a year or \$11.99 a month, and several schools in the area have begun working with them. However, games have been seen on the cable channel, albeit delayed from the original broadcast date.

Minutes:

As the May 31, 2022 meeting with Mr. Mike Heyden from The Raynham Channel was purely informational, the minutes from the April 26, 2022 meeting had yet to be approved.

Mr. McAfee made the motion to approve the minutes of the April 26, 2022 meeting and was seconded by Mr. Medina. The motion passed unanimously.

Update on Outreach to Attorney William Solomon Re: Cable License:

Mr. Solomon has drafted a legal agreement to send to the new Town Administrator confirming that he will provide information to the cable advisory committee for free either via Zoom or two times in person for free. However, the agreement needs to be approved by Ms. Ellison first before any meetings can be scheduled. Even though Fairhaven is not currently up for license renewal, it is possible to ask Comcast for an HD channel as those are now becoming a standard part of new contracts, as mentioned earlier. Until a meeting can be arranged with Mr. Solomon, the committee will continue to reach out to other towns for further information about their own cable models.

Broadband Study Committee Update:

Mr. McAfee covered the move of the Broadband Study Committee to a Municipal Light Board which will have responsibility over the project going forward. Mr. Frates informed the committee that Fairhaven received \$250,000 for the Community Compact Cabinet Municipal Fiber Grant. There will also be grants from the Massachusetts Broadband Institute as well as the possibility of federal grants. These grants will cover the upcoming the trial program as well as community education about the broadband program. Their next meeting will be September 22, 2022. Other Business:

There are currently no plans for an October meeting given the timing of Halloween event. There is a hope to meet with Mr. Solomon before the end of the year, however arranging the special Town Meeting on November 15, 2022 is also a scheduling concern.
