

Fairhaven Council on Aging • Board Meeting Minutes December 12, 2023

- 1.) The meeting was legally posted on December 7,2023
- 2.) The meeting was called to order by Martha Reed at 9:03am
- 3.) Meeting Minutes:
 - a. Jacqueline Kenwothy made a motion to accept the minutes from the September 12 2023 meeting, Lee Allaire seconded, vote passes.
- 4.) Financial Report:

Currently at 40% of the operating budget. Any major repairs that have been conducted have been covered by the Facilities Department.

5.) Old Business:

- a. Holiday Winter Activities and Events: COA Christmas Party is upcoming. Entertainment Jordan Paiva has cancelled. He has been replaced with Eddie Freitas and we will do Music Bingo.
- b. FY25 Capital Request and Budget season update: Currently level funding the budget, asking for a part time outreach worker. Also received estimates to replace the moving wall as it is need replacement. It would cost approximately 14K and does not meet the threshold. A discussion will be in the future with the Town Administrator as well as accounting.
- c. Veteran's Day Luncheon and Parade Participation: Both events were well attended. 6 people rode the bus and over 50 attended the luncheon. Thank you to All Trust Bank.
- a. Thanksgiving Dinner Update: Over 50 people were in attendance for Thanksgiving and all donations had covered the food.

6.) New Business

- a. Hybrid Programming Grant Award: The Hybrid Grant was approved and it will go live on April 1st. This grant will allow us to reach those in the community who are not able to come to the center. It will also include two times a month, a mobility course, that includes home safety due to the 30% increase in fall related calls this year.
- b. Proposal gift cards for SHINE councilors: Open enrollment has finished. Dianne and Carolyn are just fantastic. They have helped over 200 people during open enrollment and Martha would like to reward them with gift cards that will be purchased out of the gift account. The board had a great response and unanimously agreed to reward Dianne and Carolyn with the use of funds from the gift account.
- c. Setting up an emergency fund: There are times in the community that seniors have emergencies that are small but impactful. There are not a lot of resources for those who need it. Martha would like to set up a small incidental fund every year that does not

- anticipate to exceed \$1,000.00. The Board unanimously agreed to set up a small fund for residents only that are in need.
- **d. AARP Tax Senior Tax Services:** AARP is coming back in February. Paper work that goes along with the tax preparation should be available shortly as well as the days/times to book appointments. This is a free service for basic refunds.

7.) Directors Report

<u>Senior Center/Program Utilization:</u> The Senior Center hosted a total of 425 events in November. 614 unduplicated persons attended these events total of 2,471 units of service (swipes). The daily utilization rate for the center in November was 88. SHINE Counselors continued with Open Enrollment and assisted 88 clients with Medicare and Medicaid enrollments in November.

<u>Transportation Utilization:</u> 217 Rides were provided to 87 seniors in November. Will not be going to the Warwick Mall due to the bridge issues in RI, another place will be decided shortly.

<u>Volunteers</u>: 19 volunteers provided over 500 hours of service at the COA in November, with a value of almost \$14,000.

<u>Community Needs:</u> 4 Seniors were assisted with SNAP recertification's and new applications. Two seniors were assisted with housing applications. 4 new households were assisted with CSFP services.

<u>In-person event highlights:</u> 54 Seniors participated in Supper Clubs in November. 54 Seniors participated in the congregate lunch program, 53 persons were served a Thanksgiving Meal, and 30 persons attended the Memory Café.

<u>Programming</u>: The COA Christmas Party is scheduled for 12/20, we are grateful that we were able to secure a replacement for the entertainment for the party, as Jordan Paiva notified us that he had to cancel his performance due to health issues. The entertainment will be Christmas Music Bingo hosted by Eddie Freitas.

<u>Hybrid Programming Grant</u>: EOEA has awarded us \$17,727.59 for Hybrid Programming for Councils on Aging.
