## Meeting called to order 6:33pm.

Minutes: Motion to approve minutes from December 6, 2023 (MJ Carvalho, M Kelly). Motion passed with N. Mello abstaining.

#### **Commission Bills:**

- Motion to reimburse W. Oliveira for expenses from Home Depot to repair the bulkhead at the Academy Building in the amount of \$46.32. (MJ Carvalho, R. Martin). Motion passed with W. Oliveira abstaining.
- Motion to pay invoices from Fall River Gas Co., for furnace service at the Academy Building; Eversource, monthly utilities;
  Boulanger & Sons for alternator for antique fire apparatus totaling \$1347.32. (MJ Carvalho, N. Bekemeier). Motion passed unanimously.
- Motion to pay Home Depot for lighting for the fire station in the amount of \$118.92. (MJ Carvalho, R. Martin). Motion passed unanimously.

#### Chair Report:

- Budget review done with Town Budget Team on December 12, 2023 level funded in all areas except the Old Stone Schoolhouse which will go from \$800. To \$100. Possible Schedule Z credit from turbine energy to offset the Academy Building utilities – C. Durant to follow up.
- Sign for Cooke Memorial Park on order. Perhaps try to get some publicity when the sign is installed.
- Historical Commission webpage is being updated.

## Properties update:

- Academy Building: Bulkhead repaired. Work has begun on the front door. Furnace serviced on December 7, 2023.
- Fire Museums:
  - Washington Street Planning to hang old photos soon.
  - o Spring Street Looking for period appropriate display case. Some discussion about making one of these exhibits interactive and age appropriate for children.
- Fort Phoenix: Flag is replaced as soon as possible after windstorms. Awaiting response from BPW regarding the memorial that has grown at the Fort. What is the appropriate time to allow such memorials? Is there a policy? W. Oliveira to follow up with BPW.
- Old Stone Schoolhouse: The sidewalk should be improved in the spring.

## Discussion/Action Items:

- We acknowledge and appreciate the donation from John Woodford of Woodford Holding Co. DBA Rubber Duck Carwash in the amount of \$500.
- Draft of the Annual Report was discussed, and editorial changes were made. Motion to approve the draft as amended (N. Mello, MJ Carvalho). Motion passed unanimously.

- Lagoa Committee: MJ Carvalho is frustrated by lack of attendance at the committee meetings. She is seeking new members.
