

V. Items for Action

A. Road Work Article – FY19

Mr. Ristuccia – We spoke about the road work to be done at one of our last next meetings. The Board has had time to think about the roads and the ones they would like to do. I'd like to take comments from the citizens.

Bruce Hasstlehurst, 134 Ebony - We put in a petition to get the road paved. Hoppy and Keith know it's in pretty rough shape; potholes, after you grade it, it washes right way. Dust, can't open windows and when there is a snow storm it's a mess.

Scott Pomfret, 142 Cottonwood - I am one of the West island Improvement Association board members. Mark Rasmussen came by to see us in regards to the side streets and the silt into the ocean. Top of Causeway at the Fir Street intersection is horrible. In October I asked for repairs at Causeway and Fir. My mom lives at 152 Fir. There has been a puddle there forever. Mark said he can help us to get help for the town.

Paul Letendre, 80 Fir Street - There are a lot of sections that are bad. Fir and Misty Bay there is always a puddle. The other side is mud and the corner. I called a couple times last summer. Gravel gets washed away.

Suzanne Lachat, 2 Billy's Way – I brought pictures last time. It's a mess at the bottom and a pool at the end of that street.

Mike Poirier, 148 Fir Street – It's been bad for so long at the intersection of Causeway at Fir. Most traffic with town vehicles as well.

Mr. Hobson – I can feel sorry for these people. Every street does have a problem. When I first came on the board eight years ago we did a section of every street every year. We only have \$350,000 and I know we can't do all these streets but Ebony, Fir, and Bluepoint would be one of my choices. Not all of Ebony but a section each year another section next year. Chapter 90 might be able to use down the road but some of these street including Billy's Way it's a waste of manpower and dirt going there three, four, or five times a year. Streets like Bayview Avenue, the street is terrible.

Mr. Silvia – I'm working on Ebony and its rough on 1/3 of it just before Fisherman.

Mr. Furtado – I didn't look at that.

Mr. Durant – Mr. Pomfret; great point with the environmental factor. People's cars beating to their home also factors of what Scott mentioned and Hoppy about quahogs and the bay. More as an environment issue, east and west instead of north and south.

Mr. Wotton – I'm going to stick with what I said, number one pick with the highway superintendent, unfortunately not on West Island. Number one not only from the two superintendents but the road

management company. My other recommendation would be Fir and Billy's Way and 1/3 of Ebony which would be fair for everybody. We can't put \$350,000 on West Island. Try to do one street a year.

Mr. Ristuccia – I live on West Island so I really understand the road conditions down there. Should be focusing less energy of bringing gravel and more on paving. Realistic not be able to pave all of the streets this year. We can formulate a plan. There are a lot of gravel roads throughout the town. Money has to be spread. Buzzards Bay Coalition; I'm going to suggest for Mr. Furtado to reach out with those folks to see what we can get done. Worse one is Bluepoint east and west. Ebony is worse on the south side of Littleneck.

Mr. Furtado – The West Island Improvement Association contacted me about doing Ebony, Littleneck to Fisherman. Cost of the paved roads is going to be higher if we keep putting them off. Extend the money as far as we can. Hope and Billy's Way; they come every single year. Bluepoint environmental concerns and a section of Ebony.

Mr. Wotton motioned to approve with conjunction of Chapter 90 money, Billy's Way, Bluepoint, Hope and a portion of Ebony either one-third or one-half. Mr. Hobson seconded. Vote unanimous.

B. Gravity Construction; Jeannette Street Drainage, Payment #1, \$70,133.75

Mr. Furtado – This is for the drainage improvements with Chapter 90 money. The residents came here a couple years ago.

Mr. Wotton motioned to approve payment #1 to Gravity Construction in the amount of \$70,133.75. Mr. Durant seconded. Vote unanimous.

C. Award Bid Cleaning & Redevelopment of Wells; Wolf Island Road, Mattapoisett Dennis L. Maher Co., LLC \$30,600.00

Mr. Furtado – Last week we had the bid opening. Wells at Wolf Island Road are infiltrated with sand and hurts pumping capacity. This bid won by Dennis L. Maher, Co. Tata & Howard is the consultant engineer.

Mr. Wotton motioned to award to the lowest bidder, Dennis L. Maher in the amount of \$30,600 for the cleaning and redevelopment of wells at the Wolf Island Road Pumping Station. Mr. Hobson seconded. Vote unanimous.

D. Sewer Rates

Mr. Furtado – Kathy put together a table. Currently the rate is \$6.65 per hcf, raising the rate an additional .25, .35 or .50 and the projected increase. My recommendation would be \$7.00 even, which we would collect approximately \$150,000. We need that money. Certainly the folks who are on a limited budget won't be scuffling.

Mr. Wotton – We tabled this from last week because there was no camera. The dollar amount will be about \$1.17 per month. \$7.00 for your bill every six months based on 2000 cubic feet.

Mr. Durant – This is because of the nitrogen project mandated by the EPA.

Mr. Hobson motioned to increase the sewer rate an additional .35 to \$7.00 per one hundred cubic feet effective April 1, 2018. Mr. Durant seconded. Vote unanimous.

E. Appoint 2 Board Members for Highway Department Truck Driver Interviews

Mr. Ristuccia – I'd like to be one.

Mr. Durant – If you do it on the day of meeting I would do it anytime.

Mr. Wotton motioned to approve subcommittee of Mr. Ristuccia and Mr. Durant. Mr. Silvia seconded. Vote unanimous.
