

Mr. Hobson - Do we supply and clean the uniforms?

Mr. Furtado - We provide 11 shirts and 11 pants through the uniform company. If the employee does not want the shirts from the uniform company, they can buy up to 11 shirts and be reimbursed up to twenty dollars per shirt.

Mr. Hobson – Do we check their uniforms every day? The point that I am trying to make is some of the uniforms are extremely dirty and unacceptable. The way the employees look reflect on the Town. We should make sure they are wearing clean uniforms and if not they should be made to change.

Mr. Wotton – If you see an employee that has a uniform that is not up to standards they should be made aware of it and they should have to get rid of that uniform.
