



Fairhaven Board of Selectmen P 1: 21 Meeting Minutes November 2, 2020 AIRHAVEN,

Present: Chairman Daniel Freitas, Vice-Chairman Robert Espindola, Selectman Keith Silvia, Town Administrator Mark Rees, and Cable Access Director Derek Frates

Present via Zoom: Town Counsel Tom Crotty, Administrative Assistant Vicki Oliveira, Cable Production Coordinator Eric Sa, Geoff Haworth, Jeff Lucas, Cathy Melanson, Planning Director Paul Foley, and members of the public.

The meeting was videotaped on Cable Access and Zoom meeting application.

Chairman Freitas opened the meeting at 6:32 pm in the Town Hall Banquet Room and read the following statement:

"This Open Meeting of the Fairhaven Board of Selectmen is being conducted remotely consistent with Governor Baker's Executive Order of March 12, 2020, due to the current State of Emergency in the Commonwealth due to the outbreak of the "COVID-19 Virus."

In order to mitigate the transmission of the COVID-19 Virus, we have been advised and directed by the Commonwealth to suspend public gatherings, and as such, the Governor's Order suspends the requirement of the Open Meeting Law to have all meetings in a publicly accessible physical location. Further, all members of public bodies are allowed and encouraged to participate remotely.

The Order, which you can find posted with agenda materials for this meeting allows public bodies to meet entirely remotely so long as reasonable public access is afforded so that the public can follow along with the deliberations of the meeting.

Ensuring public access does not ensure public participation unless such participation is required by law. This meeting will allow public comment related to the posted agenda items only. For this meeting, Fairhaven Board of Selectmen is convening by telephone conference/video conference via Zoom App as posted on the Town's Website identifying how the public may join.

Minutes

Mr. Espindola made a motion to approve the minutes of October 19, 2020 – Open Session. Mr. Silvia seconded. Vote was unanimous. (3-0)

Mr. Espindola made a motion to approve the minutes of October 20-21, 2020 – Open Session. Mr. Silvia seconded. Vote was unanimous. (3-0)

Town Administrator's Report

Bids were opened for the Academy Building project, one for the front door restoration and the second for the handicap access project. Since the Commission didn't have enough money for both projects, the

Historical Commission decided to go forward with the Handicap Access portion and has awarded the contract to Kneeland Construction out of Medford Mass at a cost of \$149,175 and to seek funding for the front door restoration at the next town meeting.

The Town was recently awarded a \$14,300 grant through the state's Sustainable Material Recovery Program. The Board of Public Works, with the assistance of the Board of Health, is anticipating using the funds to enhance Fairhaven's hazardous waste day collection program.

The Police Chief has said the department is moving forward with being fully accredited by the Massachusetts Police Accreditation Program with the required internal assessment being completed by December 9, 2020. The Fairhaven Police Department was awarded the initial certification for accreditation status in September of 2019 and are now moving forward with full accreditation status. This accreditation is a coveted award that symbolizes professionalism, excellence and competence and as a community we should be just proud of the department's accomplishments.

Mr. Rees has approved the Police Chief's appointment of Fairhaven resident Josue Ostolaza has new police officer in the department, subject to his passing required tests and graduating from the police academy. Mr. Ostolaza comes highly recommended, is currently a corrections officers at the Bristol County Sheriff's Office and has earned an Associate's Degree in Legal Services from the Community College of Rhode Island. He also a Marine Corp. Veteran who served during Operation Iraqi Freedom.

Chris Carmichael started today as the Town's Building Commissioner he and Mr. Rees and held a brief meeting with the other inspectors in the department to introduce him to them and to talk about ways the department operations can be streamlined and improved going forward.

Committee Liaison Reports

Mr. Espindola said he met with the Bikeway Committee and members Mat Coes and Lois Callahan are working on a video that will highlight the Fairhaven bike path.

Mr. Espindola met with SRPEDD where they held a conference on climate change.

Mr. Espindola said the Broadband Study Committee has received approximately 104 surveys back so far.

Mr. Silvia said the Library has not met since the last Selectmen's meeting.

Mr. Freitas expects Bristol Aggie to meet soon.

Request to join Cultural Council

Mr. Espindola made a motion to appoint Wendy Drumm to the Fairhaven Cultural Council. Mr. Silvia seconded. Vote was unanimous. (3-0)

Mr., Espindola made a motion to appoint Suzan Galpin to the Fairhaven Cultural Council. Mr. Silvia seconded. Vote was unanimous. (3-0)

Request to join Conservation Commission

Mr. Espindola made motion to appoint Cory Pietraszek to the Conservation Commission. Mr. Silvia seconded Vote was unanimous. (3-0)

Mr. Espindola made a motion to appoint John Dallen to the Cultural Council. Mr. Silvia second. Vote was unanimous. (3-0)

The Board will recommend Ronnie Medina to the Conservation Commission to an associate position.

Open Meeting Law Complaint- Stephane Robbins

Mr. Rees told the Board that Town Counsel has reviewed the Open Meeting Law complaint filed by Stephane Robbins and has drafted a response for the Board stating that the Board was not in violation of the Open Meeting Law. (Attachment A)

Mr. Espindola made a motion to authorize Mr. Rees to send the response letter to the Attorney General's office and to Mr. Robbins. Mr. Silvia seconded. Vote was unanimous. (3-0)

Union Wharf: Property Available for Disposition, Art 11, Oct 20, 2020 Special Town Meeting

Mr. Espindola made a motion to declare the town property at Union Wharf available for disposition as per Article 11, at the October 20, 2020 Special Town Meeting. Mr. Silvia seconded. Vote was unanimous. (3-0)

Joint meeting with the Planning Board—to fill vacancy appointment: Jessica Fidalgo

Via Zoom, members of the Planning Board, Jeff Lucas, Geoff Haworth, and Cathy Melanson met in a joint meeting with the Board of Selectmen for the purpose of appointing someone to the vacant seat on the Planning Board. This position will be held until the next election. There was one applicant interested in filling the vacant seat. Jessica Fidalgo answered questions, via Zoom, and explained why she would like to be appointed to the Planning Board.

Mr. Espindola made a motion to appoint Jessica Fidalgo to the Planning Board until the next election. Mr. Silvia seconded. Vote was unanimous. (6-0)

Continued Public Hearing: Fairhaven Meadows, LLC, d/b/a Nasketucket Bay Vineyards: Farmer's Series Pouring License

Mr. Rees told the Board Mr. Christy is aware that he needs to submit more information before the Board can approve the license.

Mr. Espindola made a motion to continue the public hearing until November 16, 2020. Mr. Silvia seconded. Vote was unanimous. (3-0)

Robert Hobson- Lobster Basin, Union Wharf

Robert Hobson and Michelle Potter met in the Banquet Room with the Board regarding Union Wharf. Mr. Hobson feels that the Town is giving away spots at Union Wharf that should belong to the commercial fishermen. Town Counsel explained that back in 1943 the Town owned all of Union Wharf but reserved ownership of the basin and the right to use the lobster basin. Town Counsel said permission to use the land can be revoked at any time. Ms. Potter and Mr. Hobson urged the Board to "do what is fair." Planning Board member, Jeff Lucas, feels the Planning Board and other committees should review this as they are there to assist the Board of Selectmen in their decisions.

Mr. Espindola made a motion to ask the Marine Resources Committee to address the Union Wharf issue and make a recommendation to the Board of Selectmen and to ask the Economic Development Committee to also review. Mr. Silvia seconded. Vote passed. (2-1)

License Agreement with Casey Boat Realty, LLC

Mr. Rees told the Board that Town Counsel has drafted a license agreement with Casey Boat Realty, LLC but there has been no response back as of this meeting from Casey Boat.

Audit of Building Fees

Mr. Rees read a memo from Auditor Zachary Fentross of Melanson and Heath who stated that after an investigation into way Building Department calculate charges for payment fees. Mr. Fentross does not feel there is any fraud taking place in the Building Department and he offered several recommendations for improvements to the collection system to ensure consistency with calculating fees. (Attachment B)

Town Administrator Recruitment position statement

Via Zoom, Paradigm Associates Consultant Sharon Flaherty, reviewed the position statement with the Board. Mr. Espindola said he would like to see Acushnet included in the education portion of the statement. Mr. Freitas and Mr. Silvia requested more time to read the statement, as they had received the updated version at the meeting. Mr. Rees suggested holding a special Selectmen's meeting to discuss the changes. (Attachment C)

Mr. Freitas left the meeting at 7:54 pm

Vice- Chairman Espindola took over the meeting.

Screening Committee for Town Administrator search

Mr. Rees told the Board three positions on the screening committee have been filled. John Farrell Jr. will represent the Planning Board, Bernie Roderick will represent the Finance Committee and Colin Veitch will represent the School Committee.

Mr. Espindola made a motion to table the screening committee agenda item. Mr. Silvia seconded. Vote was unanimous. (2-0)

Annual Board of Selectmen Goal setting session

Mr. Rees said the practice over the last 3-4 years is to have the Board of Selectmen establish the Goals and Objectives, but Mr. Rees feels this would be better suited to wait until the Town hires a new Town Administrator when Mr. Rees retires in January.

Notes and Announcements

Dear Mr. Robbins:

The Board of Selectmen has reviewed your complaint dated October 20, 2020 in which you allege that the Board violated the open meeting law on September 21, 2020 and October 19, 2020.

With respect to the September 21st meeting:

- There were approximately people in the meeting room that night. The meeting was not in violation of the governor's Covid-19 order. In any event, the Open Meeting Law does not compel compliance with the governor's Covid-19 order.
- There was no need for any of the Selectmen to recuse themselves from the discussion with the ZBA or A-1 Crane. But in any event the Open Meeting Law does not govern recusals.
- The joint meeting between the Board of Selectmen and the Zoning Board was properly noticed and properly held. After that meeting members of the zoning board stayed for the discussion with A-1 Crane. That was not a joint meeting opf the two boards. Members of the ZBA stayed in attendance on their own volition, and there were no mutual or separate deliberations and no decisions made by the two boards with respect to A-1 Crane. There was no violation of the Open Meeting Law.

A There was aveather dater a complaint dated oct 20, 2020 but the oct 25 complaint was the same as the earth complaint

• The manager of Douglas Wine and Spirits submitted that matter to be approved administratively, as is common practice. That is not a violation of the Open Meeting Law.

With respect to the October 19th meeting:

- There were approximately people in the meeting room that night. The meeting was not in violation of the governor's Covid-19 order. In any event, the Open Meeting Law does not compel compliance with the governor's Covid-19 order.
- The fact that you were not recognized to speak is not a violation of the Open Meeting Law. This was a regular meeting of the Board of Selectmen, not a public hearing or public forum. The Open Meeting law does not require that meetings of public bodies be opened up for members of the public to speak.



Instructions for completing the Open Meeting Law Complaint Form

The Attorney General's Division of Open Government interprets and enforces the Open Meeting Law, Chapter 30A of the Massachusetts General Laws, Sections 18-25. Below is the procedure for filing and responding to an Open Meeting Law complaint.

Instructions for filing a complaint:

- o Fill out the attached two-page form completely and sign it. File the complaint with the public body within 30 days of the alleged violation. If the violation was not reasonably discoverable at the time it occurred, you must file the complaint within 30 days of the date the violation was reasonably discoverable. A violation that occurs during an open session of a meeting is reasonably discoverable on the date of the meeting.
- o To file the complaint:
 - o For a local or municipal public body, you must submit a copy of the complaint to the <u>chair of the public body</u> **AND** to the <u>municipal clerk</u>.
 - o For all other public bodies, you must submit a copy of the complaint to the chair of the public body.
 - o Complaints may be filed by mail, email, or by hand. Please retain a copy for your records.
- o If the public body does not respond within 14 business days and does not request an extension to respond, contact the Division for further assistance.

Instructions for a public body that receives a complaint:

- o The chair must disseminate the complaint to the members of the public body.
- o The public body must meet to review the complaint within 14 business days (usually 20-22 calendar days).
- After review, but within 14 business days, the public body must respond to the complaint in writing and must send the complainant a response and a description of any action the public body has taken to address it. At the same time, the body must send the Attorney General a copy of the response. The public body may delegate this responsibility to its counsel or a staff member, but only after it has met to review the complaint.
- o If a public body requires more time to review the complaint and respond, it may request an extension of time for good cause by contacting the Division of Open Government.

Once the public body has responded to the complaint:

- o If you are not satisfied with that the public body's response to your complaint, you may file a copy of the complaint with the Division by mail, e-mail, or by hand, but only once you have waited for 30 days after filing the complaint with the public body.
- When you file your complaint with the Division, please include the complaint form and all documentation relevant to the alleged violation. You may wish to attach a cover letter explaining why the public body's response does not adequately address your complaint.
- o The Division will not review complaints filed with us more than 90 days after the violation, unless we granted an extension to the public body or you can demonstrate good cause for the delay.








#### **Position Statement**

Fairhaven, MA (16,000 pop.), is a charming seaside community located on the shore of Massachusetts' Buzzards Bay,

approximately one mile from New Bedford, 35 miles east of Providence, R.I., and 50 miles south of Boston. Fairhaven is a community of homes, commercial development, the marine trades, and industrial companies. The Town, settled in 1653, has a rich history dating back to the days of the Pilgrims. Fairhaven was incorporated in 1812 after separating from New Bedford and grew in prosperity during the whaling days in the 1800s. The Town's most remarkable features are the magnificent European-style public buildings built between 1885 and 1906 by Standard Oil Company executive and millionaire Henry Huttleston Rogers, a native of the Town.

Fairhaven has an S&P rating of AA+ and an FY21 operating budget of approximately \$52 million. Fairhaven's population skews slightly older than the state average with approximately 20 percent of residents in the over 65 age group compared



to the state average of about 15 percent. The Town tends to be fiscally conservative. Fairhaven's current challenges include the implementation of necessary wastewater treatment plant upgrades which will be funded via the Sewer Enterprise Fund, implementing the recommendations of the Public Facilities Improvement Plan of which the first priority is a Public Safety Facility, enhancing collaboration and unifying Town staff as well as a desire for economic development that will allow the community to retain its rural charm and character. Fairhaven's local government is led by a three-member Board of Selectmen.

To serve as the second Town Administrator since this form of local government was enacted in 2014, Fairhaven is seeking a seasoned, collaborative leader with strong financial acumen, who has the ability to unify and make difficult decisions, has strategic vision, excellent communication skills, and experience with economic development and personnel management. Candidates should have a bachelor's degree (advanced degree preferred) in public administration or a related field. Preferred candidates will have a proven record of leadership, exceptional financial skills, and be able to build strong, collaborative relationships. The Town Administrator should be approachable and highly communicative. Given Fairhaven's seaside location, candidates should understand coastal resiliency issues and the importance of the blue economy.



#### Government

Fairhaven has a Board of Selectmen-Town Administrator form of government with Representative Town Meeting. The <u>Board of Selectmen</u> serves as the Town's principle elected executive board and, acting through the Town Administrator, are responsible for the day-to-day operations of town government. The Town Administrator position was established via a Special Act in November 2014. The first Town Administrator, who is retiring, established support for the position and instituted the shifts in power and responsibility required by the Special Act. The next Town Administrator must exhibit professionalism, superior substantive knowledge, and confidence.

Fairhaven has a number of elected positions, boards, and committees including: Board of Selectmen, School Committee, Board of Public Works, Planning Board, Board of Health, Housing Authority, Commissioner of Trust Funds, Town Clerk, and Town Moderator. Fairhaven has two fire stations, a central police department, one library, and its own school department with two elementary schools, a middle school, and a high school. The elementary schools were built within the past eight years. High school students may also attend either Greater New Bedford Regional



Vocational-Technical High School or Bristol County Agricultural High School. The Town of Acushnet has no high school and Acushnet students are, therefore, able to choose from New Bedford High School, Fairhaven High School, Bristol Aggie, and GNBVTRHS. In recent years, Fairhaven has been successful in drawing many students from Acushnet and this has resulted in very significant financial benefit for the Town.

#### **Finances**

Fairhaven has an FY21 operating budget of approximately \$52 million. The Town is typically conservative with its spending, but strongly supports investing in the upkeep of its historic buildings. In FY20, free cash was certified at \$4.39 million, the Town had a General Fund Stabilization Fund of \$3.09 million and General Fund Capital Stabilization Fund of \$5.66 million. The FY20 tax rate is \$11.06 for residential and \$22.04 for commercial, industrial, and personal properties. The property tax base is nearly 86% residential, about 10.7% commercial, and approximately 1% industrial. Nearly 45% of the Town's revenue comes from the tax levy, with about 17.3% from state aid. Local receipts bring in about 25% of the annual revenue. New growth in FY20 was \$229,325. The Town's non-Proposition 2½ excluded debt service ratio is currently 0.55% of the budget with projections that it will rise to 0.83% in FY22, 1.8% in FY23, 1.19% in FY24, and 1.11% in FY25. At the October Special Town Meeting, the Finance Committee noted that there was a 2021 shortfall in revenues of \$877,572. The amount has been covered through \$387,399 in cuts in the general fund operating budget and \$490,173 from free cash/surplus revenues.

Like most municipalities, Fairhaven is facing potential revenue constraints due to the ongoing COVID-19 crisis as well as the overall pressure of increasing costs and infrastructure needs. Preferred Town Administrator candidates will have exceptional financial acumen with a proven record of building balanced budgets that reflect needs while adhering to the Town's financial policies and respecting its limited resources. It is important for the next Town Administrator to maintain the good working relationship with school officials that currently exists.

According to a 2017 Moody's issuer comment, Fairhaven has a robust financial position, and a strong socioeconomic profile with a sizable tax base. It has a moderate pension liability with an affordable debt burden. Commercial businesses are located primarily along Route 6. There is a desire for some economic development to help fund town services, support infrastructure needs and provide additional employment for residents, but available land is limited.

The Town has made a concerted effort in recent years to seek and apply for grants and has been very successful in doing so. The new Town Administrator should be willing to continue these efforts to add to Fairhaven's revenue and allow the Town to provide services that would not otherwise be attainable.



#### **Economic and Community Development**

Fairhaven is a seaside community with a working waterfront. While retail trade is now the leading segment of the economy, fishing and ship maintenance are still important segments. Acushnet Company, a leading manufacturer of golf equipment, is located in Fairhaven, and there is a burgeoning healthcare-driven job cluster along Route 240. The Town's economic development goals include preserving the financial viability of the working waterfront, maintaining healthy commercial occupancies along Route 6 and other commercial areas, supporting mixed-use projects, support of small business incubation and growth, and collaboration with New Bedford and other area towns on workforce training and regional economic development. The Northeast Maritime Institute (NEMI), located in the Town Center, is a private college that offers training and education for careers in the maritime industry. Maritime-related business in Fairhaven represents a small but vital industry cluster and it is an important aspect of the Town's legacy and identity. The next Town Administrator should be ready to study the benefits an institution of higher education in the Maritime field provides in our community and be able to work with leadership at NEMI to support their expansion plans. As the Town is largely built-out, future development will mostly consist of redevelopment. Nearly 90% of businesses in Town can be considered "small business." Apart from the commercial and industrial areas and three working farms, Fairhaven is mainly a quiet residential community. The next Town Administrator will be expected to help advance the goals and objectives detailed in Fairhaven 2040, the Town's master plan.

#### **Open Space and Recreation**

Fairhaven strives to preserve and protect its agricultural resources and landscapes, cultural and historic places, open space, recreational, and forest and marine resources. The Town has a total area of 14.1 square miles and 29.4 miles of shore property as well as significant rural areas, including three working farms. Fairhaven is home to a public state beach overlooking Buzzards Bay, two large public parks, several recreational marinas, commercial wharves, a yacht club, historical Fort Phoenix and the Rogers buildings, and provides free walking tours of scenic and historic sites. Candidates should understand the value of protecting open space, coastal waters, and historic structures. The Town is bordered by the Acushnet River and New Bedford to the west, Mattapoisett to the east, Buzzards Bay to the south, and Acushnet to the north. The Fairhaven Recreation Department oversees youth sports programs, a fitness room, a summer youth program, and school vacation programs as well as adult exercise, wellness, and day trip programs each year.

#### **Current projects**

- Approximately \$30+ million for wastewater treatment plant upgrades to be funded through the Sewer Enterprise Fund via sewer user fees. This project is scheduled to begin in 2026.
- A \$1.4 million high school turf field project to be funded with surplus revenue and \$200,000 from the high school's trust fund.
- Ongoing maintenance of infrastructure.

#### **Potential projects**

- Implementation of the \$110 million Public Facilities Improvement Plan of which the first priority is a new public safety facility, expected cost of about \$50 million, which would require a Proposition 2 ½ override.
- Work with committee to determine best use of the former Rogers School building.
