September 10, 2018 Meeting Minstee 25 A 9: 38

ENRHAVEN.

Present: Chairman Daniel Freitas, Vice Chairman Charles Murphy, Clerk Robert Espindola Town Administrator Mark Rees, and Administrative Assistant Vicki Paquette.

Mr. Freitas called the meeting to order in the Town Hall Banquet Room at 6:36 p.m. The meeting was recorded by Cable Access. An audio recording was made for the purpose of minutes.

MINUTES

Mr. Murphy motioned to approve the minutes of the July 16, 2018 meeting, open session as amended. Mr. Espindola seconded. Vote was unanimous. (3-0)

TOWN ADMINISTRATORS REPORT

Mr. Rees updated the Board on several matters:

- Mr. Rees told the Board that he recently signed a contract for fiber optics for the Town, this will enhance our communications and security
- Mr. Rees and Harbor Master, Tim Cox have appointed Chris Siwik as the part-time Assistant Harbor Master and Shellfish Warden
- Mr. Rees praised the work of the Fairhaven First Responders and the Harbor Master for their help when a cruise ship lost power recently in Buzzard's Bay
- Mr. Rees told the Board that he signed the contract for the snow guards and the slate roof repair at Town Hall and he hopes to have the work to begin soon

Fairhaven Board of Selectmen – September 10, 2018 Open Session – 1

- Mr. Rees, along with Historic Commission Chairman Wayne Oliveira met recently with Architect John Montano regarding the renovation project at the Academy building
- Mr. Rees stated that the Dog Park Study Committee held its first meeting on September
 5, 2018. Selectmen Espindola has agreed to be the ex- officio for that committee
- Mr. Rees reported to the Board that there have been 12 applicants for the Custodian's position and the position for Conservation Agent is currently being advertised
- Mr. Rees updated the Board regarding the Beach Street cleanup. The work has been completed and the EPA will begin planting in September or October to restore the interidal area.

COMMITTEE LIAISON REPORT

Under Committee liaison report:

- Selectman Espindola stated that the Economic Development Committee will be meeting this Thursday, September 13, 2018
- Selectman Espindola told the Board the Wellness Committee will be starting another step challenge for all Town Employees
- Mr. Espindola said that he has been looking into a Municipal Fiber Network and will report back once he has more information

AGREEMENT WITH POLICE UNION

Mr. Rees explained that the Town and the Police Union have reached an agreement regarding a Police policy requiring all officers to carry and administer Narcan Nasal Spray as a part of the department's first responder practices.

Mr. Murphy made a motion to authorize the Town Administrator to sign the agreement between the Town of Fairhaven and the New England Police Benevolent Association Local 64. Mr. Espindola seconded. Vote was unanimous. (3-0) (Attachment A)

REQUEST TO USE TOWN HALL AUDITORIUM

Mr. Rees informed the Board that an application for the use of the Town Hall Auditorium had come in. The applicant was looking to use the upstairs for a small wedding ceremony for approximately and hour on Friday, November 9, 2018 when Town Hall will be open. The building would not need to be opened up special for the wedding. Mr. Murphy made a motion to waive the security deposit and the fees but the applicant will need to sign the indemnification agreement. Mr. Espindola seconded. Vote was unanimous. (3-0)

DECLARATION OF SURPLUS ITEMS

Mr. Rees reminded the Board that the Town's annual auction of surplus items will be held this Saturday, September 15, 2018 at the BPW garage on Arsene Street. Selectmen Murphy will serve as auctioneer. Mr. Murphy made a motion to approve the list for the annual auction and declare the items to be surplus. Mr. Espindola seconded. Vote was unanimous. (3-0)

STATEWIDE MUTUAL AID AGREEMENT

Mr. Rees reported to the Board that the Statewide Mutual Aid Agreement is a program started by the State under MGL Chapter 40 Section 4J that allows the Town to gain and provide mutual aid from other Towns in the event of an emergency. Mr. Murphy made a motion to authorize the Town Administrator to sign the agreement on behalf of the Board of Selectmen. Mr. Espindola seconded. Vote was unanimous. (3-0)

RECCLASSIFICATION OF THE BUILDING COMMISSIONER

Mr. Rees explained to the Board that the recent opening for the position of Building Commissioner needed to be reclassified in order to meet the requirements of the position. The first round of applicants, although produced several applicants, none had the qualifications for Commissioner. Mr. Murphy made a motion to approve the Building Commissioner Reclassification. Mr. Espindola seconded. Vote was unanimous. (3-0) (Attachment B)

FY20 BUDGET AND TOWN MEETING CALENDAR

Mr. Rees presented the Board with a draft of the FY20 budget and meeting calendar. With the exception of the date for the Board of Selectmen Goal setting workshop, all the dates were agreeable to the Board. The Selectmen agreed on a new date of October 27, 2018 for the goal setting workshop. Mr. Murphy made a motion to approve the FY20 Budget and Town Meeting Calendar as amended. Mr. Espindola seconded. Vote was unanimous. (3-0) (Attachment C)

RECREATIIONAL MARIJUANA BALLOT QUESTIONS

Town Counsel Thomas Crotty, Town Planner Gloria McPherson, Police Chief Michael Myers and Cathy Melanson, all members of the Marijuana Communication Committee, were in attendance to meet with the Selectmen. Attorney Crotty explained that there are several different ways questions regarding marijuana may go onto the ballot, and which method applies depends on the nature of the question presented to the voters.

Under marijuana laws, a ballot question must be voted on and approved in order to prohibit one or more types of marijuana establishments, limit the number of marijuana retailers to fewer than 20% of the number of licenses issued to package stores, or limit the number of any type of

marijuana establishment to fewer than the number of medical marijuana treatment centers in the town. Any or all of those questions may be placed on the ballot at a regular or special election by a vote of the board of selectmen.

Also under marijuana laws, a ballot question must be voted on and approved to allow on-site consumption of marijuana products. That use is not allowed in town unless it is petitioned by not fewer than 10% of the number of voters voting at the state election preceding the filing of the petition, and approved by vote at the next biennial state election following a petition signed.

Under the general law regarding local elections, a non-binding public opinion question, which could address any number of proposals regarding marijuana, may be placed on the ballot at a regular town election by the selectmen, or upon petition by 10% of the registered voters.

Based on updated interpretation of how to count package stores the minimum number of retail marijuana business that have to be allowed in Fairhaven without a ballot question is **three** (3), not two (2) as previously thought.

Mr. Espindola had some concerns for the change in numbers. Mr. Murphy is concerned if the Town does not have a ban approved by January 1, 2019, once the moratorium is lifted will the Town be at risk? Ms. McPherson stated that the Town could be at a small risk, however, anyone applying for a license has to have a Public Hearing six months prior to the license being issued.

Mr. Murphy had concerns about the costs associated with holding a special election on this matter. Town Counsel explained that the Massachusetts Attorney General's office has extended the moratorium for another six months in some cities and towns. If the Town wanted to put a limit on the number of locations for recreational sales, this would have to be done by a Town Meeting action with a by-law for retail sales. Any less than that would have to go on a ballot.

Mr. Espindola posed the question of adding the question to the upcoming State Election. Attorney Crotty explained that this could be very confusing to do because there would need to be two sets of machines and two ballots and extra poll workers.

Chairman Freitas was worried about the possibility of a potential law suit. Attorney Crotty stated that if the question is on the ballot to have fewer than three marijuana retail stores, there is a potential for having claims. The General Law states that you cannot "unreasonably restrict" someone from applying for a license. So, someone could sue if we were so restrictive that no one could apply.

Residents Bernie Roderick, Doug Brady, Gary Lavalette, Beverly Rassmusen and Cathy Delano spoke in favor of putting this question on the ballot. They are worried about the effects of recreational marijuana and what it will do to the quality of life in Fairhaven. Tim Keogh from BASK, Inc. told the Board that his business has been here for over a year and most residents do not even know that he is here. All his patients go through a strict process to obtain their medical card. His facility is safe and regulated.

Ms. McPherson explained to the Board and the concerned residents that the Planning Board is moving forward addressing the regulations. She further noted that social consumption of marijuana is not allowed. The regulation only is for retail outlets, to purchase the product and go home.

Planning Board member Cathy Melanson told the Board that the Chair of the Planning went before the Selectmen at the last meeting on his own and not as a member of the Planning Board.

The Board of Selectmen after careful thought and discussion agreed to not pursue any further action.

SPECIAL TOWN MEETING REVIEW OF POTENTIAL ARTICLES

Mr. Rees read the list of potential articles for the Special Town Meeting to be held on Tuesday, November 13, 2018. Robert Hobson asked the Selectmen about the bill he has for attorney fees from the recent tied race for Board of Public Works. The Board agreed that they would submit an article for Mr. Hobson to be reimbursed for the amount of \$1000.

MARINE RESOURCES COMMITTEE

Frank Coelho, Chairman of the Marine Resources Committee and member Michelle Potter were in attendance to meet with the Selectmen to discuss the future of the Committee. Mr. Coelho had some concerns because, although they have a full membership, they are having a hard time reaching a quorum each month when they meet. Mr. Coelho feels that he isn't getting any help from the Board of Selectmen. Mr. Rees explained that the Board is in the process of reviewing all Boards and Committees and to create charges to define the duties of each group and the limits on membership amounts. Mr. Rees told Mr. Coelho to have his committee continue to meet each month and to work on the current issues they have been dealing with. Mr. Murphy made a motion to accept the resignation on the Marine Resources Committee of Patrick Souza, Vincent Mandfredi, and Mike Cordiero. Mr. Espoindola seconded. Vote was unanimous. (3-0) . Mr. Espindola made a motion that the Marine Resources Committee remaining five members be considered the members of the Committee so that three will be a qorum until the charge is revised. Mr. Murphy seconded. Vote was unanimous. (3-0)

RECOGNITION OF VIETNAM VETERANS

Resident Cathy Melanson came before the Board to request that the River Avenue overpass be named in honor of two Vietnam War casualties. Ms. Melanson told the Board that Fairhaven had four casualties from the Vietnam War. Out of the four men who lost their lives, two have been honored. David Drown (David Drown Boulevard) and Peter Roy (I-195 overpass on New Boston Road). Ms Melanson would like to see the other two men honored as well. She has spoken to Representative William Straus to present the idea of having the east bound side of the I-195 overpass named in honor of Donald Roger Desmarais and the west bound side of the I-195 overpass named in honor of Henry Anthony Chevalier. Once Representative Straus receives a letter from the Selectmen with their approval he will move forward on having these men honored by naming the overpass. Mr. Murphy made a motion to have a letter sent to Representative Straus in recognition of the two men and have the overpass named for them. Mr. Espindola seconded. Vote was unanimous. (3-0) (Attachment C)

VOLUNTEER/ APPOINTEE HANDBOOK

Mr. Rees presented the final draft for the Boards and Committees Handbook created by Human Resources Director Anne O'Brien with the assistance of Vicki Paquette, Assistant to the Town Administrator. Board members agreed that the handbook will be a useful tool for Boards and Committees. The handbook will be placed on the Town Webpage and printed copies will handed to board and committee members. Mr. Murphy made a motion to adopt the handbook as written. Mr. Espindola seconded. Vote was unanimous. (3-0)

OTHER BUSINESS

- Mr. Murphy offered condolences to the Family of Kathy Souza, wife of retired Police Chief Gary Souza
- Mr. Murphy offered condolences to the owner of the Pasta House, Mario Ribeiro on the passing of his mother
- Mr. Murphy praised the Fairhaven Police and Fire Department for all their efforts recently when his Mom fell and they responded to his home
- Mr. Murphy thanked all those that attended the Our Lady of Angels Feast recently
- Mr. Murphy thanked the organizers in the West Island Improvement Association for
 putting on a great show in August. Fairhaven resident and mentalist Jon Stetson put on a
 great show to raise funds for that organization.
- Mr. Espindola told the Board how impressed he was at the recent graduation ceremony for the Northeast Maritime Academy. He and Mr. Rees attended the ceremony on Saturday, September 8, 2018 in the upstairs auditorium of Town Hall.
- Mr. Freitas wished Mrs. Murphy a speedy recovery from her recent fall.

At 8:32 pm Mr. Murphy made a motion to adjourn and go into executive session and not to reconvene in open session to under MGL Ch. 30A Section 21(a)(2) to discuss the Town Administrator's contract renewal. Mr. Espindola seconded. Vote was unanimous. (3-0) Roll call vote: Mr. Murphy in favor, Mr. Espindola in favor, and Mr. Freitas in favor.

AGREEMENT BY AND BETWEEN THE TOWN OF FAIRHAVEN AND THE NEW ENGLAND POLICE BENEVOLENT ASSOCIATION LOCAL 64

WHEREAS, the Town of Fairhaven ("Town") is a municipal corporation duly organized under the laws of the Commonwealth of Massachusetts;

WHEREAS, the New England Police Benevolent Association Local 64 ("Union") is the certified bargaining representative for police officers and sergeants of the Town;

WHERAS, the Town and the Union are parties to a collective bargaining agreement ("Agreement");

WHEREAS, the Police Chief, acting in his authority, instated a policy, effective July 16, 2018, requiring all officers to carry and administer Narcan Nasal Spray as a part of the department's first responder practices (see Attachment A);

WHEREAS, the Union demanded to bargain the policy under the premise of a "change in working conditions" (see Attachment B);

WHEREAS, the Town and the Union have successfully negotiated a settlement in regards to the Narcan order;

NOW THEREFORE, in consideration of the terms contained herein, the parties agree to the following:

- 1. Additional Pay: The parties agree that the Town will compensate the members of the Union with an annual first responder bonus of \$1,050.
- 2. <u>Additional Duties</u>: The parties agree and acknowledge that this additional pay is in consideration of the additional duties that may result from the Narcan policy.
- 3. Non-Precedential: The parties agree that this Agreement shall apply only to the instant matter and shall not, either in whole or in part, serve as precedent in any other matter or dispute between the Town and the Union and shall not create a precedent in any other matter between the parties. This Agreement neither reflects nor creates a past practice. No party hereto shall introduce this Agreement into any other case for any reason at any time except to enforce its terms.
- 4. Completeness of Agreement; Integration: This Agreement contains all of the terms and conditions agreed upon by the parties with reference to the subject matters contained herein. No other agreement, oral or otherwise, will be considered to exist or to bind either of the parties. No representative of either party to this Agreement had, or has, any authority to make any representation or promise not contained in this Agreement, and each of the parties to this Agreement acknowledges that such party has not executed this Agreement in reliance upon any such representation or promise. This Agreement cannot be supplemented, rescinded, waived, modified or amended, except by a written instrument signed by both parties.

5. <u>Interpretation and Enforcement of Agreement</u>: This Agreement will be interpreted and construed for all purposes under the laws of the Commonwealth of Massachusetts, and may be enforced only in and by the courts located in the Commonwealth of Massachusetts, which shall have exclusive jurisdiction over this matter.

Re: Building Commissioner reclassification request

In June 2018, I advertised for the Building Commissioner position. The preliminary compensation report from HRS Consulting indicated that our Building Commissioner pay range was 26.5% under the market rate for comparable communities. Mark granted my request to advertise the position with a range of \$61,512-76,985, encompassing the current non-union scale of Levels 17 and 18. Even with this adjustment, and despite casting a wide net into several trade journals, listserves, and assorted job databases, the applications received did not produce a pool of qualified candidates. While we had the pleasure of interviewing some knowledgeable people, most of them were not licensed Building Commissioners, and did not meet the minimum qualifications of the position.

Mr. Rees granted my request to extend the deadline and advertise with the salary range recommended by HRS Consulting for FY19 - \$74,648 - 90,962.² As a result of this revised salary range and extended deadline, we received six additional applications, five of which were experienced and licensed Building Commissioners/Building Inspectors. We have unanimously agreed upon our finalist from this second group of interviews, but before we can enter negotiations with this individual, I would like to request that the Board of Selectmen accept the recommendation of HRS to set a salary range of \$74,648 - 90,962 for the Building Commissioner position in FY19 (level 18 on the proposed scale).

If you have any questions, I would be happy to expand upon my request. Thank you.

¹ The HRS Consulting preliminary report recommends a pay range of \$73,184 - \$89,178 for the Building Commissioner position.

² This reflects a 2% COLA increase over the original FY18 pay scale proposed by HRS.

To my knowledge this is the only over pass/bridge left that we can have to honor these two individuals. Rep. Straus will be waiting to hear from the Board of Selectmen so he may act on this as soon as possible. It would be nice if it could be in place for Veterans Day.

As I said, I was already given the go ahead by the Board; I have spoken to Rep. Straus; now it is in your hands to give him the go ahead.

As a note Donald Desmarais is my husband Ken's cousin and as of today he can still member when his family got the terrible news it is something that stays with you.

Please let me know when you have sent Rep. Straus the acknowledgment to move forward, so I may follow up.




