Mr. Espindola made a motion to recommend Adoption for the amount of \$160,000 on Article 4: Fairhaven Public Schools Cable Television PEG Access Enterprise fund FY 20 Recommended budget. Mr. Freitas seconded. Vote was unanimous. (3-0)

Mr. Freitas made a motion to recommend Pass Over Article 7: Street Acceptance- Robert Street. Mr. Murphy seconded. Mr. Espindola recused himself. Vote passed. (2-0-1)

Mr. Espindola made a motion to recommend Adoption on Article 12: Storm Water Management. Mr. Freitas seconded. Vote was unanimous. (3-0)

Mr. Espindola made a motion to recommend Adoption on Article 13: Historic site reuse special permit. Mr. Freitas seconded. Vote was unanimous. (3-0)
