Meeting notes were reviewed from the December 6th 2016 h meeting.

Barbara Acksen motioned to approve. Ronnie Medina seconded the motion There was no further discussion

The motion carried unanimously.

Mark Rees provided an update on Bobby Brusco who will need more time for personal reasons prior to starting. He will be targeting February 1st at this point. In the meantime, he has continued to work on the equipment needs and facility needs.

Bob Espindola commented on the fact that the schedule for drafting license renewal documents as outlined by Attoreny Solomon in prior meetings, is such that, when Mr. Brusco starts, there will be a need to weave this work in with the immediate quality and programming issues.
