


# Town of Fairhaven Council on Aging





## Fairhaven Council on Aging • Board Meeting Minutes May 8, 2023

- 1.) The meeting was legally posted on May 2, 2023
- 2.) The meeting was called to order by Martha Reed at 9:05am
- 3.) Welcome new Board Member: Jacqueline Kenworthy
- 4.) Meeting Minutes:
  - a. Robert Ryan made the motion to approve of the minutes from the April10, 2023, Carol Burt Seconded.
- 5.) Financial Report:

COA Budget total: \$199,944.00 March Expenditures: \$13,009.02

Martha Reed reported nothing has been unexpected. The budget is on track to expend what is remaining and will give back to the town anything leftover.

#### 6.) Old Business:

- a. Easter Dinner: Easter dinner was successful. A total of 60 meals in person/delivery. Thank you to the Fire Fighters Association as well and United Way for helping fund the dinner. Thank you to Dorothy Cox for the chocolate donation.

- c. Summer Activities: Watercolor painting classes will be starting. The COA will also work with Champions again this year and will also involve the Kool Kids program the Recreation Center offers.

#### 7.) New Business:

- **a.** Coastline Cookout: This cookout will be a gift from Coastline, anyone is welcome to attend on May 30,2023.
- **b.** Newsletter Expansion: The newsletter will be expanded by a few pages. It will allow for us to add much more content.
- c. Moving the Monthly BOD Meeting to the Second Tuesday of the month at 9am beginning June, 2023: Lee Allaire made the motion to move the monthly meetings to the second Tuesday of the Month, Joan Mello seconded. Vote passed.

### 8.) Director's Report

### Senior Center/Program Utilization:

491 unduplicated persons attended events at the Senior Center in March for a total of 1,676 "swipes" for events last month. The daily utilization rate for the center in April was 79. AARP Tax Prep Services ended on April 18, 2023, with a total of 188 Seniors having their

tax returns prepared. SHINE Counselors continue to assist clients with Mass Health recertification's and Medicare enrollments.

<u>Transportation Utilization:</u> 243 Rides were provided to 81 seniors in April. <u>Volunteers:</u> 23 Persons volunteered over 542 hours at the Senior Center in April. The dollar value of these volunteer hours is over \$15,000.

<u>Community Needs:</u> 8 Seniors were assisted with SNAP recertification's and new applications. Community Outreach continues to ensure that households are receiving the maximum SNAP allotment they are entitled to receive, as well as help completing applications and submitting verification documentation to DTA. 4 Seniors were assisted in completing housing applications and other housing-related issues, including dispute mediation, and ADA accommodation issues. The Fuel Assistance program has been extended to 5/12. Two new Elder-At-Risk reports were filed with the Executive Office of Elder Affairs

In-person events: Both Senior Supper Clubs held in April were very well attended. The center hosted an Easter Day dinner that provided Easter Dinner to over 60 people. We are grateful to the Fairhaven Firefighters Local 1555, the United Way in New Bedford, Dorothy Cox's Chocolates, and the volunteers who helped serve or deliver dinners. The COA participated in the April Food Day Drive at Town Hall on 4/1/2023 to offer SNAP information and application assistance. The COA hosted an Intergenerational art program on Monday, 4/17/23, which brought together 8 intergenerational groups to work on an art project. The art is being displayed at Town Hall and there is a plan to show the art in the lobby of the Middle School during the annual town meeting on 5/6/2023.
