Meeting called, 7:00PM

- 1) Approval of Minutes: March 5th ! Lisa, Carolyn, 10 0 (unanimous)
- 2) March 12
 - Need Lisa to recirculate
 - No vote made
- 3) Introductory remarks from Mark

- Reserve fund transfers are being requested, per COVID-19
- Additional money being requested by Fire, \$5,000
- Trend analysis suggests that reserve fund should be sufficient and not overdrawn on top of other items

4) Fire Reserve Fund Request

- Additional vehicles have been affected, repairs requested, \$15,000
- \$18,000 would be left in reserve, accounting for the additional \$5,000 being requested

! Kevin, Carolyn, 10 - 0 (unanimous)

- 5) \$6,750 not added to contract from November
 - Money that is owed for contract negotiations (clothing allowance)
 - Missed b/c of oversight, focus was on overall contract cost, item slipped through

! Chris, Bernard, 10 - 0 (unanimous)

- 6) Omitted overtime cost based on old rates
 - → Lisa: How did we miss so much? Mark: Items came in close to town meeting, which made tracking difficult

! Chris, Carolyn, 10 - 0 (unanimous)

- 7) Capital Budget Item, allocated for police cruiser & resource officer cars
 - Items were approved separately, so they are done separately on paper
 - Jump in cost in cruisers (Ford update)
 - Base price is \$32,900 (base pkg), \$36,100 (hybrid)
 - Final price tag is \$52,000
 - Resource officer cars \$44,000 (each); \$75,000 budgeted

→ Pad: How is this vehicle used? Chief: Still used as cruisers, fully outfitted, weapon storage concerns

! Kevin, Chris, 10 - 0 (unanimous)

- 8) In preparations of reopening the town, plexiglass and safety measures
 - Expected to be fully reimbursed through FEMA grant
 - → Lisa: This is after quarantine is over? Mark: Being down now
 - May 18th for non-essential, expecting conditional requirements for buildings to open, request is preventive based on those requirement costs
 - Pad: Please put forth the articles ahead of the meeting if possible, some departments have gone into the negative; Mark agrees with this stance and will make an effort going forward

! Chris, Kevin, 10 - 0 (unanimous)

- 9) BPW request for additional article, automatic water reading system
 - Need awareness of where 90% of the water is going
 - Need meters to be less than 10 yr old, majority are

- Engineers discovered that automatic vs. fixed were \$200k apart, making the phased system more of a waste of money
- Losing money and water now because it is not fully accounted for
- → Pad: Why did the driveby system cost increase so much? Vinnie: Unclear, but the fixed cost hasn't inflated
- → Pad: What about saved labor cost, if meter readings are less required? Vinnie: Current system is archaic, rates currently support this, better for town and the BPW staff, mgmt, water savings cost
- → Bernie: This is an article for Town Meeting, not the actual financial cost? Mark: Yes, purpose is to make people aware of the change of scope
- → Pad: Would this cause rates to rise? Vinnie: No, follows an 8 year schedule
- → Bernie: Separate from EPA? Vinnie: Yes, completely separate
- → Kevin: 1.5m has been appropriated? Vinnie: Yes, so additionally 1.8m, for 3.3m total
- → Kevin: Has this cost been factored into the cost of water rates? Vinnie: This wouldn't per se, because the BPW follows the 8 year plan
- Wendy: Will help with billing (4 instead of 2)

Closing Remarks

- 10) Covid-19 Impact, Mark Rees
 - Different than traditional emergency, impact is on revenue than expenditure
 - When the economy shuts down, it impacts revenues, such as meal and hotel tax
 - Motor vehicle excise is lessened
 - State aid, sales tax
 - Reserves are in a strong position—over \$5m—which helps brunt some of the impact
 - Hold off on votes until we can better see the outcome of this emergency
 - Not probable to have a revised budget for late Ma, could use the 1/12th measure to keep the town operational in the meantime
