- 1) February 6th, Meeting
- * Attendance count changes for members and guests (was miscounted)
- Bernie, Carolyn, 4 Approve, 0 Do not Approve, 3 Abstain
- 2) Overview of the General Fund work for FinCom from Pad
- * General idea for FinCom is to go over the budget
- * Please read through the document over the next few months
- * If you have questions about various departments, please request

- 3) Letter from Mark Rees
- * 1st benchmark is free cash is 3-5%, 3.9% being recommended
- * Maintain stabilization 5%, 5.8% currently proposed
- * Capital Stabilization kept at 2-3%, 5.8% after recommendation
- * Health insurance trust fund 1.6m, 1.98m currently
- * Overlay reserve 300k, maintained
- * Other Post-Employment Benefits (OPEB) increase appropriation to 50k, offsets liability
- * Budgets are structurally balanced
- * "Status quo" budget
- * Property tax increase of 918k, conversative new growth 172k
- * State aid increase of only 1.5%
- * Expected 3% for Chapter 70, only receive 1.7%
- * Budget fully funds agreements
- * Fairhaven Schools, 21m
- * \$7000 placed for Parks Department
- * Group insurance reflects a 5% which is less than 8% recommended by consultant
- * Lisa: Licenses and permits gone down but building has gone up? Mark: Prior we received building permits for town development, but those have dropped down, residential doesn't bring in the fees that the commercial does
- * Kevin: OPEB increase, has that been consistent over the last few years? Mark: Started 4 years @ 150k, adding 50k afterwards, liability is in the 10m range
- * Pad requests for general review of the sections, Mark explains the different sorts of sections
- * Summary pg. 5-9 is overview of the budgets, majority of the pages are each department's evidence for why a request is being made
- * Lisa: Legal fees of projected vs. last year? Mark: Similar amount to last year with a small increase
- * For Selectmen 298k? Consistent with all departments, you can see the personal line items broken down
- * Kathi: Do you have an Assistant? Mark: Yes, and a licensing clerk
- * Mark discuss reclassifications for Town Administrator's office, Town Manager for HR Director
- "Ongoing discussion"

4) PSC Update

- * Knowles property was suitable for the building
- * Knowles has rescinded his offer to pursue other offers
- * Choices going forward:
- * ... Reopen the search for other pieces of land, unlikely to produce results...
- * ... 2 separate buildings, but would add significant cost...
- * ... Or, Eminent Domain for FMV
- * Lisa: Could we remediate? Mark: Yes but will be additional cost
- * Bernie: If eminent Domain doesn't work, back to square one? Mark: Yes
- * Pad: PD/FD leading this? Mark: Yes, working group led by Mark and chiefs, additional staff
- * Bernie: Taxes are low, but increasing taxes would negatively impact low income citizens
- * Capital stabilization would be used for land and architecture
- * Debt exclusions would be request at Town Meeting to pay back the debt
