## I. GENERAL BUSINESS:

### II. PUBLIC HEARING:

a) PL19-017 Utility Pole #43216, in town public right of way, adjacent to 6 Fort Street, Fairhaven Ma 02719.

Cellico Partnership d/b/a as Verizon Wireless is requesting a Special Permit application for installation of small Cell Equipment. Installation includes (1) Cylindrical antenna side mounted at a top height of 25.9' above ground level, two (2) remote radio heads and associated wires, cable, meter and junction boxes to an existing 33' tall utility pole. Plans titled FAIRHAVEN MA SC07 rev. 08/09/2017. Assessors Plat:1 Lot No:11. (Continued from 3/26/19)

Applicant asked for a continuance to April 9,2019 due to not enough voting members present to issue a Special Permit.
