The meeting was videotaped on Cable Access and Zoom meeting application.

Chairman Robert Espindola opened the meeting at 6:32 pm in the Town Hall Banquet Room.

### **Minutes**

Ms. Powers made a motion to approve the Open Session minutes of July 28, 2021. Mr. Silvia seconded. Vote was unanimous (3-0)

Ms. Powers made a motion to approve the Open Session minutes of August 4, 2021. Mr. Silvia seconded. Vote was unanimous (3-0)

#### Town Administrator's Report

Ms. Graves attended the Massachusetts Collectors and Treasurers Association 50th Annual School at UMass Amherst to retain her certifications as a Certified Massachusetts Municipal Treasurer & Certified Massachusetts Municipal Collector. Some of the classes that she attended were Coaching, Performance Management & Discipline, Seasoned Treasurers/Collectors Test your Skills, Economic Update, and OPEB Assumptions & Pitfalls. Ms. Graves also taught the Tax Takings Forms Workshop class for the second year.

Ms. Graves and Town Accountant, Anne Carreiro have been working to finalize the agreement with a grant consultant who will provide unlimited grant support as well as development support for five (5) grant proposals of varying complexity. Selectmen Espindola has examined the information that we received from the grant consultant and is supportive of this service.

Ms. Graves told the Board the positivity rate for COVID continues to rise and has nearly doubled since last week. The Board may want to consider initiating a mask mandate for inside all Town buildings.

Ms. Powers made a motion to put up a mask advisory on the entrance of Town Hall. Mr. Silvia seconded. Vote was unanimous. (3-0)

#### **Committee Liaison Reports**

Ms. Powers said she had her first meeting with the Cable Advisory Committee where Cable Access Director Derek Frates updated the committee on the latest happenings in his Department.

Mr. Silvia met with the Historical Commission last week. Historical Commission member M.J. Carvalho was successful in locating a historic marker after being lost for many years. MassDOT will install the maker back onto the Rt. 6 overpass.

Mr. Espindola said he has been busy working with a Broadband consultant to try to gain some ARPA funds.

Mr. Espindola will be meeting Fairhaven resident Jacob Miller, Senior Policy Adviser/Community Development Director to Senator Montigny regarding the visit of the Ambassador from Great Britain on September 2, 2021.

Mr. Espindola announced the Executive Session for tonight is tabled until a future meeting.

# Nicole Podkowa 5K Road Race: October 2, 2021

Mr. Espindola said organizers for the Event have reached out to the Police and will coordinate a safer route.

Ms. Powers made a motion to approve the Nicole Podkowa 5K Road Race on October 2, 2021, contingent upon Police approval. Mr. Silvia seconded. Vote was unanimous. (3-0)

#### **Economic Development Committee Appointment**

Chairman Espindola read letters from Nils Isaksen and Travis Rapoza requesting to join the Economic Development Committee. Mr. Rapoza stated he is interested in getting involved in the community. Ms. Powers made a motion to appoint Travis Rapoza to the Economic Development Committee. Mr. Espindola seconded. Vote passed. (2-1)

#### Alternate SMMPO Appointment

Mr. Espindola told the Board he would like to appoint Planning Director Paul Foley as the alternate to the SMMPO in the event that Mr. Espindola can not make a meeting, Mr. Foley could go in his place. Ms. Powers made a motion to appoint Mr. Foley as the alternate to the SMMPO. Mr. Silvia seconded. Vote was unanimous. (3-0)

#### Representative Appointment to the Rogers Reuse Committee

Mr. Espindola updated the Board on the appointments to the Rogers Reuse Committee. The Finance Committee has appointed Lisa Plante as their representative and the Planning Board has appointed Wayne Hayward as their representative.

#### Fall Town Meeting

The Board discussed the idea of holding a Fall Town Meeting. Ms. Graves will reach out to the Town Clerk for some possible dates. The Board will discuss further at a future meeting.

#### Atlas Tack terms of engagement

Ms. Graves explained the town is looking to hire Peirce Atwood to advise the Town on potential liability in the tax taking of Atlas Tack. (Attachment A) Ms. Graves explained Atlas Tack is in tax title for approximately 1 million dollars.

Ms. Powers made a motion to enter into the contract with Pierce Atwood. Mr. Silvia seconded. Vote was unanimous. (3-0)

Mr. Silvia left the meeting at 7:02 pm

#### Representative Appointment to the Town Administrator Search Committee

Mr. Espindola updated the Board regarding the Town Administrator Search Committee. The School Committee has appointed Pam Kuechler, the Finance Committee has appointed Robert Grindrod, the Planning Board has appointed David Braga and the Board of Public Works has appointed Cameron Durant as their representatives to the Town Administrator Search Committee.

#### Town Administrator Search Committee Select Board Representative appointment

Mr. Espindola said each Board member is allowed to make one appointment to the Town Administrator Search committee.

Selectman Espindola made a motion to appointment Leon Correy as his representative on the Town Administrator Search Committee. Ms. Powers seconded. Vote was unanimous. (2-0-1)

Selectwoman Powers made a motion to appoint Kimberley Trahan as her representative on the Town Administrator Search Committee. Mr. Espindola seconded. Vote was unanimous. (2-0-1)

#### Town Administrator Search Committee At-Large vacancies

Selectman Espidola and Selectwoman Powers each provided their choice for the at-large candidate.

Ms. Powers made a motion to appoint Anne Morton Smith to the at-large position on the Town Administrator Search committee. Mr. Espindola seconded. Vote passed. (2-0-1)

Ms. Powers made a motion to appoint Gloria Perparas to the at-large position on the Town Administrator Search committee. Mr. Espindola seconded. Vote passed. (2-0-1)

Gloria Perperas and Anne Morton Smith (via zoom) told the Board they are grateful for the opportunity to serve on the committee and looking forward to the process.

Resident Ann Richard, via zoom, inquired why Ms. Graves was in the room. Ms. Graves said she was not applying for the Town Administrator position.

#### **Town Administrator Search Position Statement update**

Mr. Espindola said the consultant is still in the process of updating the draft of the Town Administrator Search Position Statement.

Mr. Espindola said the executive session to discuss the Opioid Litigation Update has been tabled to a future meeting.

At 7:22 pm Ms. Powers made a motion to adjourn. Mr. Espindola seconded. Vote was unanimous. (2-0)

Tom,

Copied here are the questions, with my answers inserted.

- 1) Was this work anticipated when the budget was created such that the cost is already covered in our existing legal budget?
- 2) What is the estimated cost of this work in total?

The estimated cost of the legal analysis and summary of the town's potential CERCLA liability is \$3500 - \$4000. If the town wants us to assist with redevelopment efforts or related issues, we can do so at an additional cost. Our involvement - and the associated cost - is flexible.

3) Will the contract or P.O. for services establish a "not to exceed" amount (for hourly expenses and additional charges) that Peirce Atwood would need to have additional expenses above that amount authorized?

We did not establish a not-to-exceed amount for this work because the initial scope is limited; we are analyzing the town's potential CERCLA liability associated with a tax taking. Going forward, if we are asked to assist with other efforts associated with the Atlas Tack property, we could set a not-to-exceed amount.

4) Will Town Counsel be involved also or will you be the primary point of contact to share all of the history, files, etc?

I don't expect that we will need all of the history, files etc. for our current scope of work. I obtained a copy of the consent decree.

5) Will Pierce Atwood be consulting with government agencies, like the EPA and/or the DEP as part of their consulting work?

Yes, we will be (and have been already) in contact with EPA and the Department of Justice, and MassDEP as necessary.

Feel free to pass these responses along to the Town Administrator and Chair of the Board of Selectmen with your thoughts on question 1. Otherwise, let me know if I should respond directly to Wendy Graves.
