c) CON-19-017 Nasketucket Bay - off Fish Island

Notice of Intent filed by the Town of Fairhaven for batch permitting for Town aquaculture grants, to authorized licensees at all times of the year, in, upon, or from a 6-acre aquaculture development area in Nasketucket Bay off Fish Island to: (1) plant and grow shellfish both on and off the bottom; (2) place shellfish in or under protective devises affixed directly to the tidal flats or land under coastal waters; (3) harvest and take legal shellfish; (4) plant cultch for the purpose of catching shellfish seed; and (5) grow shellfish by means of racks, rafts, or floats. Work to take place within Coastal Waters, Land Under Coastal Waters, Tidal Flats, and Land Containing Shellfish.
