AGREEMENT BETWEEN THE CLTY OF NEW BEDFORD AND THE TOWNS OF DARTMOUTH AND FAIRHAVEN, MASSACHUSETTS, WITH RESPECT TO ESTABLISHMENT OF A REGIONAL VOCATIONAL SCHOOL DISTRICT

This agreement is entered into pursuant to Chapter 428 of the Acts of 1971, between the City of New Bedford and the Towns of Dartmouth and Fairhaven, hereinafter referred to as member municipalities. In consideration of the mutual promises herein contained, it is hereby agreed as follows:

SECTION I: THE REGIONAL DISTRICT SCHOOL COMMITTEE

A. Composition

The powers and duties of the regional school district shall be vested in and exercised by a regional district school committee, hereinafter sometimes referred to as the Committee. All appointments to the Committee to be made by any member municipality, and the filling of any vacancy thereon, shall be made in a member town by the joint action of the Chairman of the Board of Selectmen, the Town Moderator, and one member of the School Committee, to be designated by said committee for this purpose; and in the City of New Bedford by the Mayor with confirmation by the City Council. If a Town has no school committee because it is a member of a twelve-grade regional school district, the appointment and the filling of vacancies to be made by such towns shall be made by the joint action of the Chairman of the Board of Selectmen, the Town

Dear Ms. Ellison,

It is with great enthusiasm that I recommend Wayne Oliveira for reappointment to the Greater New Bedford Regional Vocational Technical High School District School Committee. Wayne has been a tremendous asset to the Committee since becoming a member in May, 2019. Over the last four years, like many schools, Greater New Bedford Voc Tech battled through a global pandemic that challenged all of us in unprecedented ways. Most notably, as school committee members, we were challenged to help navigate a school district through challenging fiscal waters while simultaneously adopting policies and practices to reflect the changing educational reality. The pandemic brought more than two years of financial uncertainty, student learning loss, and a renewed focus on the safety and security of school buildings. Additionally, like more than 20% of school districts since the pandemic (including Fairhaven), our school committee selected a new Superintendent Director, and have begun the process of reallocating resources to more effectively service students in a post Covid-19 world.

These challenges require consistency on the GNBVT District School Committee. Throughout the last four years, Mr. Oliveira has demonstrated the judgment, perseverance, and commitment to stand on his principles while supporting vocational technical education for our town and the region. Despite the official ending of the Covid-19 national emergency, there remains the work in educational districts to recover from the pandemic in an evolving world. Wayne has consistently put forth his best efforts, attends all meetings and conferences, volunteers on subcommittees for the Committee, listens to constituent concerns, asks probing questions during school committee meetings, and collaborates effectively with the school's administration. As you know, serving on Town Boards and Committees is not easy work. We need dedicated, hard-working, and focused individuals ready to carry out this important work on behalf of our community.

It is without hesitation that I recommend Wayne Oliveira for reappointment to the Greater New Bedford Regional Vocational Technical High School District School Committee.
