Livesey Park has two tennis courts, two basketball courts and a street hockey rink that are used daily during three seasons of the year. The Fairhaven Tennis Association spearheaded the project in 2017 to repair and resurface all three of these facilities and they held up well until the winter of 2022-23 when a number of wide cracks appeared. (See attached photos.) By the summer of 2024 it will have been seven years since they were last done. Delaying this project will only cause these well used facilities to get much worse and approach being unplayable. The cost to replace such facilities is about five times the cost of this requested repair and resurface project. The Fairhaven Tennis Association will pledge \$5,000 towards this project.

A qualified contractor will clean all of the asphalt areas of the basketball and tennis courts, as well as the street hockey rink. All surfaces will then be power washed. Approximately 150 feet of previously repaired cracks will be removed and replaced with appropriate materials to strengthen those areas. New cracks will be repaired using the Riteway Crack Repair system that includes a fiber glass mesh over all of the repaired cracks. Then one coat of resurfacer will be applied to all of the surfaces at the tennis and basketball courts, as well as the street hockey rink. Next, two coats of Nova combination paint (blue and green) will be applied to all surfaces. Lastly, the appropriately white lines will be painted on each of the tennis and basketball courts as well as the street hockey rink.

The Fairhaven Tennis Association will pledge \$5,000 towards this project. Please see the attached proposals from East Coast Sealcoat Abington, MA.




